



The Commission Investment Fund is allocated to ServeNebraska to provide training and technical assistance to AmeriCorps programs in Nebraska.



Public Health Solutions

The Public Health Solutions AmeriCorps program aimed to fight food insecurity in their local health district including Saline, Fillmore, Thayer, Jefferson, and Gage counties. The program's goal was to provide nutrition education by implementing sixweek education courses.



Girl Scouts Spirit of Nebraska

Girl Scouts Spirit of Nebraska was funded for a planning grant during the AmeriCorps 2019-2020 program year. Their objective was to design an AmeriCorps program that would expand services to prevent bullying through the "Be a Friend First" program and develop volunteers.



Scottsbluff Public Schools

Women's Center for Advancement

The WCA AmeriCorps program consisted of five AmeriCorps members who assisted with different aspects of the organization's services. They served in the Clothing Boutique providing professional clothing to beneficiaries, as law clerks assisting legal teams with research and development, and as community prevention and education specialists to engage men in the prevention of violence.



The Scottsbluff Public Schools AmeriCorps program focused on serving at-risk and low-income students in the school district through mentorship, educational assistance, family involvement, workplace prep, and skill building aimed at improving academic performance and engagement.



Literacy Council of GI

The Literacy Council of Grand Island was funded for six AmeriCorps members to teach literacy courses for adults in Grand Island, Nebraska, This included guiding students through digital coursework and providing individualized support to students at the Community Connection Center. The program intended to increase access to education, employment and economic stability.



College Possible

The College Possible AmeriCorps program focused on making college admission and success possible for students in the Omaha metro area. In 2020, their 32 AmeriCorps members adapted to the COVID-19 pandemic by moving their services to a virtual space while maintaining the support that helps students thrive.



Nebraska Conservation

Members serving with the Nebraska Conservation Education Fund AmeriCorps program strived to educate Nebraskans on how to keep our state beautiful. Fortyfour members strong, they led community discussions, hosted clean-ups and drove engagement to address local conservation concerns.



UNK-CSP

The UNK- Counseling and School Psychology AmeriCorps program aimed to increase access to behavioral healthcare to those living in rural areas where resources can be scarce. The program placed 21 graduate level counselors-in-training in rural healthcare settings to provide screenings and treatment.

Partnership 4 Kids

The P4K AmeriCorps program utilized seven AmeriCorps members to support Omaha students through high school and college. The program shifted its services to a virtual space in response to the pandemic in 2020. They impacted students by helping them navigate their educational path and career preparation.



YWCA Adams County

The YWCA Adams County AmeriCorps program's 17 members served the community through sites in the area such as the Hastings Literacy Center, CASA Maryland Living Center, Adams County Diversion, and various YWCA programs such as the Career Closet and the Zone after school services.



RISE

The RISE (Recognizing Increased Skills in Education) AmeriCorps program was run through the Nebraska Department of Probation. Its 11 AmeriCorps members served statewide and focused on educating youth in juvenile probation to increase skills, attendance, and success in their education.
